I understand that the pet(s) named above will be the subject of a painting produced by a Paws & Paint artist, and that the image will be the artist's interpretation of my pet based on the pictures and information I provide. I understand that Paws & Paint will not start my commission until they receive both this agreement and my initial payment, which is 50% of basic fee.

I understand that I will receive a digital sketch of the image from Paws & Paint, and that my approval of the sketch will be required via email or postal mail. I understand that upon approval of the sketch, the initial payment will become nonrefundable.

After my approval of the sketch, I understand that I can only request minor changes: These may include minor color or detail changes at the artist discretion. I understand that layout, size and depth of the canvas, theme, style, material, design and major color changes will not be accommodated. I also recognize even minor changes may extend the time frame of the project. I understand that the artist is not liable for the delay of the completion of the project.

Upon my approval of the final image to be sent in digital format by Paws & Paint, I am responsible for the remaining balance due, including shipping fee, sales taxes, if any, and any other additional costs. I understand that Paws & Paint will not ship the painting until the final payment is received and verified by PayPal or a financial institution. I understand that it may take approximately two weeks to have my payment verified by the financial institution. I understand that the shipper is one of the commercial business that Paws & Paint agrees to use, and I understand that Paws and Paint will not accept any under-/over-payment of the total cost or any order or payment from overseas. I understand that sale is final after the shipment of the finished project. After the shipment, I understand that if there is a minor color change or other requests, the artist will work with the painting at my cost of shipping. I understand that the art work is not returnable to Paws & Paint and that I will not receive a refund of my payment.

I assign and authorize Paws & Paint all rights to the photography I send. Also, I understand that without limitation Paws & Paint holds the full and complete copyright and reproduction right to copy, exhibit, publish, display on a web page, or distribute copies of the painting. I will not use the image of the painting except for individual use without written permission from Paws & Paint. I expressly waive any rights or claims I may have as outlined in this contract.
